 - Reference: 18/05835/FUL (validated: 03/01/2019) Address: Proposed Barn Conversions At Earls Ditton Farm, Earls Ditton. Proposal: Conversion of traditional farm building to create 5no dwellings; re-siting and conversion of 2no dutch barns to create garaging; formation of associated parking areas including demolition of portal framed farm buildings and making good stone boundary walls Decision: Grant Permission
- (c) To receive updates on outstanding planning matters
 - i) 18/05739/FUL Earls Ditton Lane erection of two dwellings. Shropshire Council is aware that part of the site has been levelled and a large static caravan installed on-site. There are now additional structures on site which appear occupied as well as more fires in the field. Planning permission has not been granted for this latest development but there is existing permission for one dwelling.

110/09 <u>Place Plan/Community Infrastructure Levy</u> Council considered projects for the Expression of Interest Form for CIL Local funding and approved the new bus shelter and road safety measures along the A4117 to be put forward for consideration.

110/10 Unitary Councillors' Reports

Unitary Cllr Madge Shineton reported that the police Chief Constable and Commissioner attended full Council last week. Whilst they are providing an additional 115 officers there are still concerns that forces in the midlands are not working better together. There is a Crucial Crew (children's safety) Event again this summer which the parish could support financially. Economic development is being discussed in local areas such as Mullers (Cleobury) and Kudos (Neen Savage) who have a variety of skilled labour and support training and development. Cllr Shineton has taken the senior economic officer around local businesses. There are ongoing discussions regarding the hospitals among accusations of insufficient consultation and the possibility of a review by the Secretary of State, if formally requested. Band D Council Tax will be £1,415.60 for the forthcoming year. Cllr Buffery asked Cllr Shineton for her opinion on a recent motion tabled by Cllr Heather Kidd that all planning applications should be automatically called in to Committee where the officer's recommendation differs to that of the Parish Council. This would have improved transparency within the Planning process but the motion was supported by all except Conservative members. Cllr Shineton said the local member can call planning in for Committee but the Parish Council must be prepared to speak at the Committee meeting. Some difficult applications go to Committee to give them more publicity. Cllr Buffery asked what redress there is for Parish Councils not satisfied with the Planning Officer's decision if we don't feel they have considered all comments before making a decision. Cllr Shineton explained that all comments are considered and included in the Officer's Report which is published along with the Decision Notice. The only redress we have would be to go to judicial review but this is very expensive. Councillors should go to training sessions and there is one in June. It was pointed out that this is for Neighbourhood Planning, not general planning.

110/10 Unitary Councillors' Reports (cont'd)

Cllr Turner asked for more local training sessions rather than at Shrewsbury which is difficult for those who work full time. This has been requested many times, with local facilities offered, but SALC have not been willing to do so. Cllr Shineton said she was SALC's training champion and would ask them to put a note in their next bulletin about organising local training sessions. Cllr Shineton felt it was unreasonable to expect Steve Davenport to attend council meetings. Cllr Buffery said this was clearly stated at the SALC area meeting so must be misinformation.

110/11 Parish Matters/Highways

- i) There were no new highway matters raised.
- ii) The Lengthsman will coordinate the ditching work to be undertaken as part of the Environmental Maintenance Grant.
- iii) Cllr Buffery asked about the Community Speed Watch training for the new volunteers. The Clerk will chase this.

Council reviewed the drafted Annual Report which has been prepared for the Annual Parish Meeting on Monday 20th May, 7pm at Doddington. It was agreed to put together a formal annual Council report for the Chairman to read out at this meeting. Council approved this report subject to additional information about council members, the new website and dates of meetings.
