Highways

The Clerk and Cllr Shineton have been regularly reporting and chasing up our highway issues especially the damage to the road from Lodge Bank to the Crown following the recent floods.

The new Mandate to add Cllr Buffery and Cllr Turner has been confirmed in writing.

Annual Parish Meeting

The meeting is booked for Monday 18th May, 2020, 7pm at Hopton Wafers Village Hall. Philip Dunne MP will be in Parliament so cannot attend but Clive Dean, Shropshire Wildlife Trust's Reserves Officer South is happy to attend and talk about the work of SWT on Catherton Common.

BT payphones

Confirmation has been received from BT that there are no plans to appeal against any of the objections, which means that the payphones at Doddington and Crumpsbrook will remain in service.

Trees at Doddington Heights

Concerns had been raised regarding tree and hedge removal at Doddington Heights. The Tree Officer has confirmed that there are no Tree Preservation Orders or conservation area constraints affecting the site and as the land is no longer agricultural, the 1997 hedgerow regulations do not apply which means that the owners are not in breach of any regulations.

Festival at the Edge email from Sue Chand, Director

Sue Chand, Director would like to meet a representative from the Parish Council on 13th March regarding the planned storytelling festival at Hopton Court this year. They hope to make local contacts to gather information about the area that will be helpful to them and the festival goers.

Community Infrastructure Levy (CIL)

The Clerk has chased Senior Officers regarding the application of CIL Local for Vehicle Activated Signs and refurbishment of Hopton Wafers Village Hall. They promised an answer very soon.

Proposal: Outline application for the erection of 1No dwelling with detached garage and installation of septic tank (to include access)

Applicant: Mr And Mrs C Court (c/o Agent)

Outcome: Whilst Council are generally supportive of applications for people working locally, they were concerned that this application is for an open-market dwelling in an agricultural field. Council felt that more information was needed on the type of property being proposed before they could make a clear view as the parish is already well over the guideline figure for market housing and there have been previous cases of speculative market housing development. Concerns were raised regarding the very poor condition of Earls Ditton Lane and access onto the main road and that any additional development will only exacerbate the problems.

Proposal: Erection of livestock and general purpose agricultural building

Outcome: Council were concerned that the proposed building is disproportionate with the size of the plot especially on the open Common. Council queried the intended use of such a large building with industrial roller shutter doors as little detail was supplied with the application.

Proposal: Erection of one dwelling (modification to previously approved); erection of detached double garage

Applicant: Mr And Mrs B Perry (Hillocks Farm, Hopton Wafers, DY14 0EB).

At 7.40pm Council suspended Standing Orders for Mr Perry to speak. Mr Perry explained that the transformer in the field will have to be moved to accommodate the two previously approved plots. As they have been unable to move the transformer off site it will have to be placed between the two new dwellings. This means moving the proposed house next to The Dingle. The garage is an addition to the previously approved plan. Mr Perry explained that Western Power want to upgrade the electricity to the village but easements are required if the transformer is moved as it affects others land. Mr Perry asked for the Parish Council's support to move the transformer. The Chairman explained that we would need this request in writing, formally from Western Power before the Parish Council could make any comment.

At 7.45pm Council reinstated Standing Orders. Outcome: Council felt they could make No Comment on this application due to all the issues raised and to leave it with the Planning Authority to resolve.
