The Parish Council feel that development should not take place on this greenfield site which is out with the main 'built' area of the village. There is one lone bungalow adjacent to the site with a footpath, minor road and an A-road on the other three sides so we do not feel this site can be considered part of the village for development and it does not meet the criteria for a 'cluster'.

The adjacent property of Ashcroft is accessible over a public path which does not have any capacity for further traffic. The access/egress onto the main road is already difficult and additional traffic journeys will exacerbate these issues. The access into the field at the lower end of the plot was created without permission with hedging being removed. A new access was also created into the top of the field with further hedging being removed without permission from Planning/Highways. This matter is an outstanding concern of the Parish Council which has not been addressed.

The design of the properties is not in-keeping with other properties in the area but most concerning is the sheer size of the dwellings and how much they will overlook the nearest neighbours (Ashcroft and The Wafers) and would be overbearing visually being proposed to be built on such a steep bank. The gradient of the bank and considerable problems already with surface water gives great cause for concern as there is little information on how this would be managed. We understand that the sewage connection being proposed is into a private drain and would need consent.

This parish has had more than the guideline figure of market housing under SAMDev and do not wish to have any more market housing especially as there is no gain or benefit to the community. The Community Led Parish Plan's view on housing is very clear on this.
