- ii) The Boundary Review The Local Government commission are proposing that the existing Ward would be split into two. Firstly, Cleobury Mortimer town, plus Coreley, Milson and Neen Sollars PC but now also taking in Boraston and Nash. The other ward would be Hopton Wafers, Farlow, Wheathill, Stottesdon, Neen Savage, and Kinlet. They are proposing to call this ward the Stottesdon ward.
- iii) The Place Plan review has started a 12-week consultation with Town and Parish Councils.
- iv) Cllr Butler gave his apologies for the Annual Parish meeting on Saturday 20th May.

159/12 Parish Matters/Highways

- i) Speed Watch At the last speed watch in Doddington a representative from the Village Hall committee challenged the volunteers that were parked in the car park saying they needed the permission of the Village Hall Committee to do so. The Speed Watch has parked there for the last 8 years without an issue. An alternative place to park has been found but this is disappointing as it is a community facility and a community job is be undertaken.
 - There are 3 scheduled for June. One car was recorded as doing 63 MPH into Hopton Wafers and 11 were caught speeding in a one-hour period.
- ii) Cllr Jones reported that he had tried to enter a report on "Fixmystreet" for Earls Ditton Lane, but it showed as not being the responsibility of Shropshire Council. Cllr Buffery said he had reported issues previously, Cllr Jones to try and resubmit.
- iii) The Sign for the Cattle Grid on Stock Hall Lane needs cleaning and is overgrown. As the Lengthsman has not yet been appointed Cllr Jones offered to look at it.
- iv) An update was requested on the repairs to the Cattlegrid at Doddington, the clerk to chase.
