Upon review the build has some adjustments to plans which include new windows that overlook the neighbours, positioning of gates does not agree with plans and goes directly onto the road, though this could be temporary and the property is now three storey whilst the plans were for a two storey property. There is also a balcony with a room underneath but again this is incomplete. Enforcement have sent a notice saying that the window under the balcony needs to be changed. Cllrs agree that this needs to be monitored until the building works are complete.
